VAN NUYS AIRPORT CITIZENS ADVISORY COUNCIL MINUTES Tuesday, June 6, 2023

A meeting of the Van Nuys Airport (VNY) Citizens Advisory Council (CAC) was held at the Airtel Plaza Hotel 7277 Valjean Avenue, Van Nuys, California, 91406.

III. Staff Reports

A. Airport Manager Paul Herrera

Mr. Herrera thanked the audience and CAC members for their patience as we moved to adjust the start time of this meeting to 7:15 p.m. due to an error in posting the agenda last week.

Mr. Herrera reported that VNY was evaluating new venues for future CAC meetings.

Mr. Herrera noted that the FAA has published a notice in the Federal Registry to request public comments on its noise policy (NPR) and will consider making changes to how the FAA analyzes, explains and makes changes to its noise policy. The comment period is open for 90 days started approximately 45 days ago and concludes on July 31. The FAA will host a series of virtual public meetings in June. The Flight Path Museum's Scholarship program is now open for students residing in Southern California who wish to pursue careers in aviation/aerospace/aeronautics. Six scholarships will be awarded. On Wednesday, May 17th CEO Justin Erbacci joined Deputy Mayor of Business and Economic Development Rachel Freeman; Consul General of the Kingdom of the Netherlands Dirk Janssen, and

KLM Royal Dutch Airlines Chief Executive Officer Marjan Rintel to welcome a special KLM flight to LAX as part of the 2023 Sustainable Flight Challenge. The Sustainable Flight Challenge encourages airlines that are part of the Sky Team Alliance to find innovative ideas and practical solutions to operate in sustainable ways. The round-trip KLM flight from Amsterdam to LAX aimed to fly with as little carbon emissions as possible, using new and existing innovations in the industry including Sustainable Aviation Fuel and electrified ground-service equipment. LAWA shared what the airport is doing to meet its bold goal of zero-carbon emissions from airport operations by 2045.

On Thursday, May 12th LAWA hosted West Los Angeles College (WLAC), United Airlines, Alaska Airlines, American Airlines and SAI Engineering for a roundtable discussion on workforce needs so the airlines could learn more about WLAC's aviation mechanic and avionics programs. The avionics program is a new bachelors' degree program that WLAC will launch in 2024, and the aviation mechanics program is a 23-month course that provides graduates with technical certificates that allow them to earn jobs maintaining aircraft. The roundtable was part of LAWA's efforts to ensure that local community members are connected to the training programs for well-paying jobs at the airport, like the HireLAX program. Airlines will need to hire thousands of aviation mechanics, and LAWA wants to ensure that the local community knows about the rewarding career path and the training opportunities to help them acquire these positions.

On Sunday, May 7, 2023, members of the Los Angeles Airport Police Honor Guard traveled to Sacramento to attend the 45th Annual California Peace Officers Memorial. The event took place on the state capitol grounds where agencies from across the state come together to pay tribute to the fallen heroes of California. The ceremonies serve to formally enroll peace offers who have died in the line of duty and included a candlelight vigil and an enrollment ceremony. In 2022, 8 peace officers made the ultimate sacrifice protecting their communities.

The City Facilities Recycling Program (CFRP) of LA Sanitation and Environment is conducting a toiletry drive through June 23. Donations of the following unopened items are being accepted: soap, shampoo, conditioner, toothbrushes, toothpaste, mouthwash, razors, shaving cream, feminine hygiene products, and deodorant. Donated items will benefit St. Francis Center, and LA Sanitation's Livability Services Division, organizations that provide support to the City's unhoused residents. The unofficial start of summer arrived last week and LAWA's load factors were almost 90% on Thursday and Friday, the week prior to the 3-day weekend. Over a million passengers traveled through LAX over the five days from Thursday through Monday, with the highest passenger traffic on Friday the 26th with over 226,000 passengers. This was the biggest travel weekend since before the pandemic.

In April VNY conducted 29,854 aircraft operations, including operations conducted while the Air Traffic Control Tower was closed (After Hour Operations). This represents a 48.76% increase in operations as compared to April 2022 (20,068). VNY's YTD 2023 operations totals are currently up by 14.83% as compared to YTD 2022 totals. VNY's operations were affected by runway closures last year due to the capital project. RWY 16L was closed from February 21st through August 2nd. Flight training was at times limited to accommodate regular traffic.

Based on the VNY Noise and Operations Monitoring System, in April 2023 VNY had approximately 5,665 Jet Operations. This number is up 12.2% compared to April 2022 (6,356) and up .4% compared to the previous month in March (5,643). Discussion ensued.

B. Christian Moreno, Chief of Airport Operations

C. Diana Sanchez, Director of Public and Community Relations

Ms. Sanchez thanked the members for their understanding and flexibility for the meeting time change. Ms. Sanchez reminded the committee and the public that the comment period for the Vision Study is open until noon tomorrow, June 7.

Ms. Sanchez noted that the location of the August meeting will likely be in a new location so please look at the agenda. She also asked that CAC members arrive 10 minutes early for a quick photo for the website.

D. Ryan Page, Environmental Management Report

Mr. Page reported the monthly statistics for April 2023 including noise comments, Jet Early Turns and the Quiet Departure/Fly Friendly Program. The briefing summarized the information contained in the environmental reports which can be viewed on VNY's website at www.iFlyVNY.com under the Noise Management Section.

Chief Boisselle noted that VNY Airport Police has gone down in the area and the FlyAway. VNY officers have been active in trying to assist the homeless in the area. VNY Airport Police increased patrols and were able to reduce theft and to prepare for the summer travel season.

RESOLUTION NO. - One (1)-year Contract with Falcon Fuels, Inc.: By joining City of Los Angeles Contract ARC 40 22000000011 4, covering supply and delivery of renewable diesel fuel for LAX and Van Nuys Airport, for cost not to exceed \$360,000

The VNY CAC Communication Process Regarding LAWA Procurements:

Negotiations continue for an Award of Lease to a successful bidder for the former National Helicopter site east of Prop Park and south of the Sun Air Jet hangar(s). The RFP is referred to as Ground Lease Non–FBO Aviation Facility at 16750 Roscoe Blvd. This lease will be at an upcoming BOAC meeting in the coming weeks for an Award of Lease. A date for it to be placed on the BOAC agenda for consideration has not been scheduled.

Another set of Non-Aeronautical RFPs that was posted and is now closed is for an Award of Lease to a successful bidder for Ground-Mounted & Roof-Top Solar at Van Nuys Airport.

- o Ground mount solar power at a specific location.
- o Rooftop solar for up to eight (8) rooftop locations at the Van Nuys Airport.

These item(s) will be placed on an upcoming BOAC Meeting Agenda in the next few months.

Finally, the Award of Lease for 16231 Waterman Dr. (Bonseph Helinet, LLC, for the potential redevelopment of land and existing facilities at the Van Nuys Airport continues to track through the approval process with City Council.

Once the BOAC and City Council award these lease(s), the proposer will move into the project phase where the successful bidder will be invited to make a project presentation to the VNY CAC to solicit input and feedback. In addition, the CAC and members of the community will be provided with an opportunity to comment on the developments as they progress through the entitlement and/or environmental process as required by the city.
